## What is eviCore's Oncology Benefits Management program?

eviCore's Oncology Benefits Management (OBM) program supports the selection of high-quality, value-based oncology pathways, and includes management of prior authorization for Part B medications, radiation oncology, and advanced imaging.

#### When will the program begin and who will be included?

The program will begin for dates of service January 1, 2022 and beyond, and apply to Cigna Medicare Advantage plans in Arizona (Maricopa, Pima, and Pinal counties).

### What will eviCore provide prior-authorization for?

- > Part B medications
- Surgical oncology Part B medications
- Radiation oncology outpatient professional and technical services
- Advanced imaging services performed in an eviCore-contracted outpatient location

# What about drugs billed through pharmacy?

Drugs covered under the customer's pharmacy benefit will be reviewed by that customer's PBM.

# Who will be processing and paying claims?

eviCore will manage and administer all claim processing and payment functions on behalf of Cigna to eliminate split billing challenges. Claim-related instructions are provided in detail during in-service training.

### Will we need a contract with eviCore to participate in the network?

Yes, an eviCore contract will be required to participate in the network.
